Business

1. Project Opportunities

The Chair announced the resignation of Keith Biglin as Project Manager.

The Chair lead a discussion on the project opportunities.

2. Project Design and Community Consultation

The Chair lead a discussion on the project design and community consultation.

Brand Architects have developed a consultation package for the community with a questionnaire and feedback form. This consultation will run for a minimum of four weeks.

Strategy and Proposed Community Engagement Plan

- The first two weeks of engagement will be undertaken via Have Your Say website, Posters, postcards, Social media etc.
- Workshops for the second two week period, to understand needs.
- Potential for a 'drop in' centre if needed.
- Consultation to be more targeted to the current user groups in the first instance.
- Consultation will also be undertaken with Council's reference groups for advice –
 Disability Accessibility Working Group, Aboriginal and Torres Strait Islander Community.

Time sensitive: Re-brand and approval of consultation material will need to be ready by end of next week.

Need to be realistic and manage expectations for what can be delivered with the funding provided.

Opportunity to open use of the old facility for other sporting groups to utilise. The new multi sports complex may open opportunities for new user groups to participate with the new space.

It was noted that there are difficulties with the Barkly Street site due to limitations of space due to heritage buildings and an authority sewer running through the site.

Due to the possible confusion of the existing BIRC site and the new development it was discussed that a new 'Working Title' for the project should be considered. The following names were discussed.

- Benalla Multi Sports Stadium
- Benalla Multi Sports Complex
- Benalla Sports Stadium
- Benalla Indoor Recreation Centre Barkly Street
- Benalla Sport Precinct

The working group discussed that the 'Benalla Multi Sports Complex' is the preferred name.
