Business

1. Project Opportunities

The Chair welcomed the committee and handed the discussion to Laura Benson for a project update: Agreement at last meeting was to close open design items and progress to the functional design.

BPS are working with Brand Architects to develop a project brief including an option for the ECA upgrade to accommodate Multisport activities.

CEO reiterated that the business case for management model is important, to identify management structure, capital replacement etc.

2. Project Design, Community Consultation

Requests will be made for the Department to address boundary realignments/remove vegetation that is challenging for Councils. Masterplan forms basis of discussion

3. Information Sharing

What is the timeline for detailed design/funding agreement?

Early indications are that design will be nearing completion around September, but that will be subject to review periods, public exhibition, Council approvals. Development of the funding agreement can progress early next year with the scope now confirmed.

David supports the design and flexibility to accommodate other sports if possible. Regarding strategic planning, can't stress enough the importance of getting planning documents right to inform future decisions.
