Confirmation of the minutes of the previous meeting

There are no previous minutes of the Benalla Indoor Recreation Centre Redevelopment Project Streeting Committee.

Business

1. Introductions

The Chair lead committee introductions.

2. Terms of Reference

The Benalla Indoor Recreation Centre Redevelopment Project Steering Committee Terms of Reference were provided to all committee members. No comments or changes were provided.

3. Project Plan and Schedule

The Chair lead a discussion on the project plan and schedule. The project schedule will be provided to committee members once it's available.

4. Project Site, Concept Ideas and Opportunities

The Chair lead a discussion on the project site, concept ideas and opportunities.

The Benalla Indoor Recreation Centre Masterplan was adopted by the Council at its meeting on 13 November 2019. The Benalla Indoor Recreation Centre Masterplan and Council report were provided to all committee members.

- The committee discussed the Barkly Street site. MAI advised that Council is working toward an agreement to obtain the land required for the project.
- It was noted the Council gave in principle support for the Benalla P-12 College Barkly Street Campus as the preferred site location for the Benalla Indoor Recreation Centre Redevelopment project at its meeting on 24 April 2024. There may be future factors and issues that arise throughout the project that could potentially impact this site as the preferred site.
- Wally asked if the current basketball stadium at the Barkly Street site will be demolished or utilised with the new BIRC design. The Chair advised that this should be considered by the committee.
- Noel asked if squash courts could fit into the current basketball stadium at the Barkly Street site, that way it could be utilised rather than demolished. The Chair advised the structure is in reasonable condition and could be an option for the committee to considered.

5. Project Design, Community Consultation and Next Steps

Laura and Peter of Brand Architects presented the project background and preliminary concept design proposal to the committee. Laura advised that the design is indicative and provides an idea and a starting point for what the funding could provide.

Peter advised that there could be potential to allocate funds to refurbish the current basketball stadium at the Barkly Street site.

Laura and Peter also presented a draft community engagement plan and program.

6. Petition: The Council to Include Squash Courts in the Benalla Indoor Recreation Centre Redevelopment Project

A petition containing 615 signatories has been received requesting the Council include six squash courts in the *Benalla Indoor Recreation Centre Redevelopment Project*.

The Council at its meeting on Wednesday 31 July 2024 resolved, that the *Benalla Indoor Recreation Centre Redevelopment Project Steering Committee* consider the issues raised within the petition during the design stage of the *Benalla Indoor Recreation Centre Redevelopment Project*.

7. Information Sharing

The Chair discussed the importance of frequent meetings initially and would like the Steering Committee to hold fortnightly meetings in the initial stage of the project.
