#### **PURPOSE OF REPORT**

The report considers submissions received on the proposed 2024/25 Budget.

#### **BACKGROUND**

The Council at its meeting on Wednesday 1 May 2024 resolved:

- 1. That the proposed 2024/25 Budget be endorsed for public exhibition for a period of at least 28 days from 2 May 2024.
- **2.** That submissions relating to the proposed 2024/25 Budget be heard at a meeting of the Finance and Planning Committee on 5 June 2024.
- **3.** That the Council consider submissions relating to the proposed 2024/25 Budget at a Council meeting on 19 June 2024.
- **4.** That the Council consider the adoption of the 2024/25 Budget at a meeting of the Council on Wednesday 26 June 2024.

Public notice of the proposed 2023/24 Budget was given on the Council's website on 2 May 2024 and in the Benalla Ensign on Wednesday 15 May 2024.

Feedback was also sought via the Council's website and promoted on social media.

A community information session was held on Thursday 23 May 2024 at the Benalla Civic Centre.

The submission period closed 5pm Thursday 30 May 2024.

I would like to propose that the footpaths around the town are old, dilapidated and in need of repair. The new footpaths going out to the race course sounds a bit like a white elephant. And I feel money would be better spent improving the old footpaths around town. The towns gutters are in a poor state as well. Hanna street is just one example.  I am concerned that we don't have sufficient parking in the CBD. Could this be improved by having angle parking? I'm excited that your goals are to promote a flourishing thriving business and tourism industry.  I am concerned for our young people and the sense of hopelessness they feel which results in crimes and general bad behaviour. Could we engage a youth development officer to find ways to stimulate and encourage our young people. They are our future after all. I am happy with the waste management plans. U3A Benalla Committee – Margret Jenkins	Mayor, Councillors and CEO, In the Proposed 2024/25 Budget of Benalla Rural City Council (BRCC) strategic objectives of BRCC are stated as firstly Community: Council aspires to a healthy, safe and resilient community, and a connected, involved and inclusive community. This statement proceeds to say that Council supports "programs, services and activities and events that support, develop and connect community members of all abilities and lead the community to be age friendly and child and COVID safe."  Benalla has an ageing population. According to the 2021 census, 46% of Benalla's population are aged 55 years or older, as compared to 28% of the Victorian population and 29% of the Australian population. The Benalla Seniors and Community Centre is currently an excellent BRCC facility. It was built in the 1980's, and although it has had two refurbishments, has not been extended since it was built.  U3A Benalla is an organisation for retired or semi-retired people aged 55 years or older. Currently U3A Benalla occupy two rooms at the Benalla Seniors and Community Centre and offer our 408 members 46 different activities. These activities provide entertainment, enjoyment, physical activity, mental stimulation and social interaction, all of which are important for our member's mental health.  Each group or activity is organised by a volunteer Convenor who is passionate about the subject or group they are organising. In 2023 U3A Benalla realised that our Convenors, Committee, Newsletter and Website Manager contribute a total of 700 hours of volunteer work to our Benalla community each month. The two rooms that U3A Benalla occupy at the Benalla Seniors and Community Centre include the main room which is 14 m x 5m and will comfortably hold 30 people when tables are taken out of the room. The second room which is 5m x 5m will seat 10 people, and is useful for only the smallest U3A groups or one on one assistance in some programs.  Enrolments in 2024 for some of the groups which use the larger room are Music Appreciation 44

Examples of this is Wine Appreciation which has members from Albury, Wangaratta and Greta, the Creative Writing group which has members from Bonnie Doon and Wangaratta, whilst our Exercise group has members from Glenrowan and Wangaratta.</li> <li>U3A Benalla is a successful growing organisation which currently has 408 members. We had a 22 % increase in membership in 2023, and currently have a 2% increase in membership this year. We are providing 46 courses or activities which are enjoyed by our members.</li> <li>However, for U3A Benalla to keep expanding we require a room which will accommodate 40 to 45 people with adequate nearby parking and appropriate facilities. We cannot provide this ourselves.</li> <li>U3A Benalla were pleased to note that under Major Initiatives in the Proposed 2024/25 Budget of BRCC point 2 which states "Adopt and start implementation of the Fawckner Drive Precinct Masterplan".</li> <li>U3A Benalla hope that in the Implementation of the Fawckner Drive Precinct Masterplan Benalla Rural City Council will include building an extra room to accommodate groups of 40 – 45 members adjacent to the Benalla Seniors and Community Centre.</li> </ul>
3.	Roman Kaminski	BRCC Proposed Budget 2024-2025: Concerns and Call for Transparency. In the BRCC Proposed Budget 2024-2025 meeting on May 1, 2024, Cr Puna Gunaratne expressed his reservations about supporting the draft budget for community consultation. He emphasized the need to delve deeper into the budget's intricacies to fully understand its implications.  During the discussion, Cr Davis urged Cr Gunaratne to consider reducing council services and staff, and even suggested the possibility of eliminating the landfill. However, it's noteworthy that there was no mention by Cr Davis of reducing council consultancy fees or re-evaluating the leasing of the Mayor's Tesla EV vehicle. Cr Gunaratne raised concerns about certain councilors prioritizing expensive consultancy services over concrete financial data, particularly in the case of a proposed cinema project. Despite the significant costs involved, there was a lack of transparent information regarding the budgetary impact of this venture. As an engaged ratepayer, I reached out to Cr Davis for clarification on the BRCC cinema project but received no response. This lack of communication is disappointing, especially considering Cr Davis's call for constructive input from ratepayers. Similarly, my inquiry to Cr Hearn regarding the proposed Midland Hwy project (footpath from town to the Benalla Racecourse at \$150,000) yielded vague information. While acknowledging the budgetary constraints, Cr Hearn's response lacked clarity on the project's funding structure and the extent of government involvement, example is it \$1 for \$1 with state or federal governments. As a member of the community, I

		advocate for greater transparency and accountability in council decisions. Ratepayers deserve clear and comprehensive information to make informed assessments of proposed projects and their financial implications. It's imperative that councilors prioritize open communication and provide detailed insights into budget allocations, particularly for projects that significantly impact taxpayers. Moving forward, I urge councilors to address these concerns and actively engage with constituents to foster a more transparent and inclusive decision-making process. Only through open dialogue and collaboration can we ensure that the BRCC budget reflects the needs and priorities of the community it serves.

#### RE: Budget Submission on Securing a Sustainable Financial Future for Benalla Art Gallery

I write to on behalf of Benalla Art Gallery Foundation Directors to congratulate the Council on securing the \$3M grant from the Growing Regions Program (GRP) and to respectfully request the Council to consider associated Budget matters concerning future Budget years.

The \$3M grant from the GRP is great news for whole Gallery Redevelopment. Not only will it enable Council to complete Stage 1 and fix the most severe Gallery *building* problems. It lays the groundwork for Stage 2 of the Redevelopment, which is so critical to securing income for the Gallery's *operational* future. The fact that three levels of Government now support the Gallery is already instilling confidence in potential donors the Foundation is in touch with.

#### Redevelopment of Stage 2 is critical to securing Gallery's *operational* financial future.

Why? Because Stage 2 provides additional spaces for:

- Blockbuster Exhibitions that the Gallery can then stage and charge entry. Other regional galleries advise us that Blockbusters generate around \$320k p.a. for them.
- Community Outreach Programs that attract public, philanthropic and donor support.
- Restaurant and functions that generate additional regular income from rent and hire.
- A real Gallery Shop that will generate significant additional direct and on-line income.

The additional spaces will increase the number of visitors to the Gallery. Additional visitors mean more data on potential donors captured, and more income for Benalla businesses.

CRM & Point of Sale (POS) System is critical to securing the Gallery's financial future
The Gallery also needs an integrated POS/CRM System to secure its financial future- one
that can capture the data and income generated from its 80,000 visitors — or 200,000 p.a.
post Stage 2 of the Redevelopment. Additional income a CRM/POS will generate includes:

- **Commercial income** through increasing Gallery Shop sales direct and on-line and POS tickets to major exhibitions and events; through hire of spaces and more.
- **Membership Income** by following up visitors and encouraging them to join the Gallery.
- **Donor income** with the Foundation, by encouraging individuals to be annual donors.
- *Major Philanthropic income* with Foundation, by building on-line relationships with scores of public and private Trusts and Foundations and with high-net-worth individuals.

An integrated POS /CRM System can secure these financial benefits. Without it they cannot. The Directors of the Foundation are therefore pleased to advise the Council that, after exhaustive research by skilled consultants and detailed discussions with senior Council Officers, the Foundation has donated amounts that total \$27,500 to the Gallery, to enable Council to purchase an integrated CRM and POS System. FY 2025 licensing fees are covered by the donation. In discussions leading up to the decision, it was considered reasonable for licensing fees for a further two financial years to be covered by Council. Net fees p.a. to Council is anticipated to be some \$13k p.a. We hope this is acceptable, given the benefits.

In addition, the Directors of the Foundation are also pleased to advise that we are engaging PW Strategy as the **Business Development Team** to work with the Gallery, the Foundation and other supporters in raising additional capital and operational funds the Gallery needs from philanthropic sources and from establishing a Gallery Annual Giving Program. The Team involves two highly skilled professionals working part time. They have begun quietly in small ways and plan to be fully on-board by July 2024.

Dear CEO, The Mayor and Councillors.

#### RE: Budget submission 2024-2025 in relation to Benalla Art Gallery's financial future.

I would like to take this opportunity to congratulate the Benalla Council on receiving \$3K grant from the Federal Growing Regions (GRP) program for the Benalla Art Gallery.

I write on behalf of the Friends of The Benalla Art Gallery, volunteers and members in asking the Benalla Council to consider and financially support the redevelopment project in their budget allocations for 2024 -2025.

To receive grants from both State and Federal Government's clearly indicates that Government at both levels has considerable faith in the future of the Benalla Art Gallery and the aim to bring it up to the standard of other regional Galleries in Victoria.

**Stage 2**. With this grant enabling the redevelopment to progress to Stage 2, building on Stage 1 it is a critical point in the redevelopment's operational future and of considerable benefit to the future of tourism visitations and the Benalla economy.

**Stage 2** will provide the opportunity for additional the spaces, block buster and travelling exhibitions, philanthropic and donor support and return our gallery to the 'Jewel in the Crown' it once was.

Already we punch above our weight compared to other Galleries, the result of an exceptional hardworking team, volunteers and community support which is unsustainable without additional resources with the commitment and work load ahead.

I would like council to consider a budget allocation for gallery staffing that brings us up to the ratio determined by the value of our collection and in line with other regional galleries and allow the talented staff to continue to present a professional and viable Gallery.

The Gallery Director and his team have a major role in securing future funding as demonstrated by the combined application with Council to the Growing Regions funding application. Understaffing brings burnout and departure which we can ill afford and after receiving both state and federal Government grants, and support from the Director of the NGV Tony Wellwood, if we become unable to meet an acceptable level of competency it will destroy our credibility as a professional Gallery.

#### **Budget recommendation**.

I would like council to give consideration to this request for at least one additional staff member in the 2024-2025 budget to help maintain stability and lighten the work load.

#### The Foundation POS/CRM

The Formation of the Foundation and securing Government grants both Federal and State, the formation of a Business Development Team and an integrated POS /CRM system is critical to the Galleries financial future.

The CRM system enables the capture of data and income generated from the following sources. Commercial income, membership income, Donor income and Major Philanthropic income.

<u>Budget recommendation</u>. The Foundation has made a financial contribution to enable Council to purchase a system and I urge council to consider supporting this system in the budget beyond the 2024-2025 period to provide and demonstrate financial stability.

#### Philanthropic Relationships.

Philanthropists are shrewd investors with their giving and it takes considerable time to build these relationships based on the professionalism of the organisations and the benefits to those involved.

To quote the philanthropist, Rupert Myer AO, Art enriches our lives, unites our communities and ignites our economy.

Moving forward, with the support already received from government bodies, BRC Council and the public sector we are in a position to grow exponentially with the experts in our **PW Strategy Business Development Team** to work with donors, philanthropists and all stake holders in raising additional capital. This will enable the Foundation to present a totally professional organisation that will attract philanthropic relationships in support of the Art Gallery and subsequently enrich the Benalla Community.

Philanthropy is the lynch pin for securing the Art Galleries future and must be nurtured.

#### **Gallery Tourism.**

That the draft Fair Access Policy be endorsed for public exhibition for a period of at least 28 days.

The public exhibition period was opened Friday 26 April 2024.

To promote and encourage community input the following activities were completed:

- Public notice of the draft Fair Access Policy was given on the Council's website on 26 April 2023 and via Council's social media.
- Advertised in the Benalla Ensign on Wednesday 1 May 2024.
- Direct emails, meetings and communications with sports clubs, recreation facility contacts and Committee of Management contacts.

The submission period closed 5pm Thursday 30 May 2024.

The draft *Fair Access Policy* seeks to address known barriers experienced by women and girls in accessing and using community sports infrastructure and applies to community sports infrastructure where the Council is the land manager and/or operator of the facility.

#### **DISCUSSION**

At the close of the submission period one submission was received from Simon Olsen (refer **Appendix 1**).

In accordance with the Council's *Governance Rules 2020*, submitters were invited to address the Finance and Planning Committee in support of their submissions. No submitters addressed the committee.

#### PURPOSE OF REPORT

The report considers feedback received in relation to the proposed name change for the *Benalla Senior Citizens Community Centre*.

#### BACKGROUND

At the Assembly of Councillors briefing held on 30 August 2023, U3A Benalla representatives provided Councillors with a presentation on U3A activities. During the presentation U3A representatives proposed a name change for the *Benalla Senior Citizens Community Centre*.

The proposed name change was that the Centre be renamed *Benalla Seniors and Community Centre*.

Subsequently, a letter was received from U3A and Senior Citizens Benalla to indicate support for the proposed name change from user groups of the centre. Further correspondence was received from U3A on 30 October 2023.

At the 6 December Finance and Planning meeting a report regarding the proposed name change was tabled with the recommendation:

That the proposal for the Benalla Senior Citizens Community Centre to be renamed Benalla Seniors and Community Centre be placed on public exhibition for a period of at least 28 days.

The public exhibition period opened 17 January 2024 and closed 21 February 2024.

Feedback on the proposed name change was advertised through Council's website, social media and the Benalla Ensign. Additional printed information and surveys were available at the *Senior Citizens and Community Centre* and Council's Customer Service Centre. The Age Friendly Officer also presented the proposal to the Age Friendly Reference Group at their February Meeting.

#### **DISCUSSION**

At the completion of the exhibition period 46 surveys were received. 31 electronic and 15 paper.

- 31 submissions were in support. Three of the 31 included alternate suggestions.
- 14 submissions were against. Six of the 14 proposed alternate suggestions.
- One survey provided a comment with no vote.

#### **General Themes**

Those voting in the affirmative were in support as the new name was more inclusive of all users within the Centre.

Reasons for those who had voted against included, the process is a poor use of Council resources or that the proposed new name was either not required or not appropriate.

Four surveys requested that the word 'and' be removed from the name, making the name Seniors Community Centre.

Submissions are attached as **Appendix 1**.





# 4. Proposal for a Mobile Phone Tower at Goorambat Recreation Reserve

SF/5635

#### **PURPOSE OF REPORT**

The report discusses feedback received regarding the proposal to lease land for a Mobile Phone Tower at the Goorambat Recreation Reserve.

#### **BACKGROUND**

The Council received an initial briefing at an Assembly of Councillors meeting in August 2023 and a follow up briefing in February 2024 on a proposal for a Mobile Phone Tower at the Goorambat Recreation Reserve. The Manager Facilities and Information Technology, Greg Robertson presented the proposal and possible locations within the Goorambat Recreation Reserve for the tower.

Historically, phone reception in Goorambat has been poor.

## **DISCUSSION**

The lease proposed is for a 20-year duration with all lease income proposed to be directed towards maintenance of the Council owned and managed Goorambat Recreation Reserve, and the associated community sporting facilities.

Ideally the funds would be granted to a Community Asset Committee, however there is no formal management committee at the reserve yet. The informal committee at the reserve have indicated they are looking to incorporate.

In lieu of a committee the Coordinator Open Space arranges maintenance at the reserve and is in regular contact with the individual sporting groups and in the informal Goorambat Recreation Reserve Committee.

The coordinator could allocate funds to any required work until such time as a committee is established for the reserve. The guaranteed annual allocation may prove an incentive to establish a formal Community Asset Committee.

The towner will be in a small 10m x 10m fenced compound on the western boundary of the reserve.




Image: proposed 10m x 10x fenced compound for the tower.

Community engagement on the proposal opened on Thursday 29 February 2024. A public notice was published in the *Benalla Ensign* and on Council's website on Wednesday 6 March 2024.

The proposal and online submission form were published on the Council's 'Have Your Say' website.

Twenty-three online responses were received via the Have Your Say website and one inperson response. Online submissions are attached as **Appendix 1**.

Community consultation closed on 27 May 2024.

#### **CONSULTATION RESULTS AND THEMES**

# **Positive Responses**

Twenty-one responses were supportive of the proposal and many of these responses appear to be from submitters local to the Goorambat area. Written comments in-support include:

Please go ahead with this. Mobile reception is so unimaginably poor in the Goorambat and Devenish areas. In past natural disaster and weather-related emergencies, we have been without mobile reception and internet access which at times has left us physically stranded with no way to verbally communicate with emergency services and family. Going ahead with this proposal is absolutely necessary, and a much-needed life line in our small community.

- The mobile phone tower is desperately needed to improve not only general communications and internet in the Goorambat township and surrounds but also for emergency communications. I would like to see the lease fees returned to the recreation reserve committee of management for use to maintain and improve facilities at the reserve for this small community.
- Doesn't impact the use of the reserve. Urgently needed infrastructure.
- My daughter works in Goorambat we always worry they (sic) if anything happened on her trip home in the dark, she so would be completely stranded as its impossible to get any reception for most of her trip home.
- Goorambat desperately needs a telecommunications Tower as the mobile phone connection out here is extremely unreliable.
- I am very happy to have the tower as currently mobile reception is dismal. In this modern era telecommunications is everything for emergency services, business and general life.

# **Negative Responses**

Two responses were opposed to the proposal, however, neither negative response was from a person local to the Goorambat community.

One negative respondent appeared to be confused about the location of the tower and provide comment that they did not want another mobile tower located in Benalla and money should be spent on youth activities.

The second negative respondent also appeared confused about the location of the tower, believing it would be in Benalla. This respondent was also opposed to 5g mobile services, believing them to be a health hazard and preferring that 4g mobile services only are used in Benalla.

## Inconclusive Response

One response received contained no negative or positive submission, or comments, so has been disregarded.

#### In-person Response

The Manager Facilities and Information Technology spoke over the phone, and later inperson with the president of the informal Goorambat Recreation Reserve Committee. Initial concerns held by the committee included:

- The possibility of tower supporting cables impacting on parking.
- Access track reducing parking.
- Electricity supply being taken form the football clubs' power meter.
- Negative impact on plans to extend the clubs' septic system.
- A request for the lease funds to be directed back in the reserve.

In response to the concerns, it is noted that:

- the small tower compound will have no negative impact on parking and no supporting cables will be permitted under the lease. Supporting cables are not needed because the tower will be a concrete monopole.
- the access track will improve access by vehicles to the overflow parking area at the west of the reserve.
- the electricity supply will be independent and separately metered.
- works will not impact on future septic system upgrade and expansion plans.
- It would be appropriate that lease funds are directed back to the Goorambat Reserve. Initially funds would be managed via the Council's Coordinator Open Space, in consultation with the informal Goorambat Reserve Committee. Once that committee incorporates and become a Community Asset Committee the funds could be directly managed by the committee.
