- Two (2) copies of properly prepared plans including site plan, floor plan, elevations and sections, which indicate the proposed floor levels above Australian Height Datum (AHD)
- A letter from the water authority with details of the Specified Flood Level above AHD
- Copy of a current Certificate of Title including lot plan, plan of subdivision, covenants, agreements, easements
- Fee to be calculated once application form has been lodged via the online customer portal.
